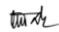

VC Locator: The VC Locator app is a Voting Center Locator developed for the Upazila Administration, offering a user-friendly solution to locate and navigate voting centers during elections, enhancing the democratic process.</li> <li>3. UP Assessment Management: Focused on empowering Union Parishads, this app centralizes and manages assessment information, facilitating effective decision-making and resource allocation for community development projects.</li> <li>4. AMAR AI (LLM and Image Generation): Under the umbrella of the ICT Division, the AMAR AI project is set to redefine the landscape of mobile applications. With a focus on Language Model Mastery (LLM) and Image Generation, this app will showcase the prowess of artificial intelligence in fostering creativity and innovation.</li> <li>5. AR STATION (Artificial Reality App): As part of the cutting-edge technology, the AR App project is poised to introduce an Augmented Reality experience. This app aims to push the boundaries of reality, offering users an immersive and interactive digital overlay on the real world.</li> </ol>

Must be a Bangladeshi firm having valid &amp; up-to-date trade license (2023-2024), TIN Certificate, Tax Clearance certificate, VAT identification number.</li> <li>2. Must have minimum 05 (Five) years of general working experience. The year will be counted backward from the date of publication of this notice.</li> <li>3. It is mandatory to have a minimum of one practical experience in developing a mobile application for any government entity within the last three years.</li> <li>4. It is preferred that the firm has published at least one mobile app in both the Google Play Store and iOS App Store, and that the app has been available in both stores for the past year.</li> <li>5. The development firm must submit Recent Bank solvency certificate or liquid asset of at least 35 lacs to carry out the project.</li> <li>6. Should have 20 (Twenty) full time ICT personnel in company related to system analysis, design, development, integration, testing, QC, training and implementation of web and mobile based applications/ software solutions.</li> <li>7. Preference will be given with AI &amp; AR App development work experience.</li> <li>8. Preference will be given to bidders with a valid ISO 9001 certificate.</li> <li>9. Preference will be given to those with prior experience working with the relevant Government entity</li> <li>10. Preference will be given to bidders with BASIS Membership.</li> <li>11. Documents demonstrating the management and operational capacity of the firm / joint venture (Brochures, Company Profile and other documents describing company expertise, strength and experience, core functions, similar assignments or project experience, availability of relevant project competition).</li> <li>12. Firms have the option to establish a Joint Venture, wherein the participating firms/entities will share joint responsibility for fulfilling all the obligations outlined in the contract. The collective number of firms involved in the Joint Venture should not exceed three (3).
